## PHARMACOLOGIST EXPLAINS DRUG COVERAGE CHANGES URGES NAMI TO DEMAND EXEMPTIONS

At the May 19 NAMI CC general meeting Dr. Doug Del Paggio reiterated the message that beginning next January, dual eligibles are likely to find their access to vital medications severely limited. "This can be a devastating change for our dual eligibles," said Del Paggio, who is a pharmacologist and director of pharmacy services for Alameda County Behavioral Health Care Services, a department of the county's health care agency.

Dual eligibles ("Medi-Medis") are individuals covered by both Medicare and MediCal. Next year, MediCal will no longer pay for their drugs; they will get their medications via a Medicare Prescription Drug Plan (PDP) operating according to guidelines set by the Center for Medicare Services. The plans will be required to provide a choice of only two drugs per therapeutic class—two antidepressants, two mood stabilizers, etc. Because the plans will be capitated—reimbursed according to the number of people enrolled instead of the cost of the prescriptions they provide—the incentive will be to offer the least expensive drug options. Also, benzodiazepines (e.g. Ativan, Klonopin) will not be covered.

As we know, the cheapest option is often not the best for an individual who is mentally ill. Older antipsychotics, for example, Del Paggio explained, are chemically different from the new atypicals and do not address the many symptoms that the new ones do. Older and newer drugs differ in their side effects as well. Offering only two drugs when more are available is like offering a person only a size 4 or a size 12 shoe, he said. "Antipsychotics are not interchangeable."

Also as we know, limiting access to appropriate meds has a huge cost in quality of life and in dollars, as hospitalizations and emergency psychiatric visits multiply. In New Hamp-

shire, Del Paggio noted, when prescriptions covered were limited to three per month, overall mental health costs went up 17 times; when Oregon eliminated coverage of medication for mental illness, hospital admissions and emergency psychiatric visits increased so drastically that the change was rescinded within six weeks. His own studies have also shown a huge reduction in hospitalizations and crisis medical visits when patients have access to newer antipsychotic medications.

The guidelines for the drug plans allow for exceptions, but prior authorization from the doctor and "fail first," will be required. More hoops, as we know, increase the risk of noncompliance. Fail first means an individual must initially try a drug covered under the plan even though there is a better alternative.

There will be no grandfathering, Del Paggio noted. That means that there is no guarantee that our family members who have been stabilized will continue to get the drugs they need to keep them that way.

He urged NAMI members to demand that Congress exclude dual eligibles from the coming change. "(Drug) plans should not decide medical necessity," he said.

NAMI CC will offer more information about the drug plans and how to lobby for change as it becomes available.

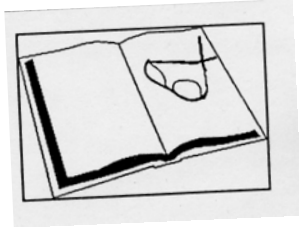

**BOOK REVIEW**

*Stop Walking On Eggshells*, Taking your life back when someone you care about has Borderline Personality Disorder. Authors, Paul T. Mason, M.S. and Randi Kreger, New Harbinger Publications, Published 1998, 258 pages, \$15.95. Available in the NAMI-CC library and at bookstores everywhere.

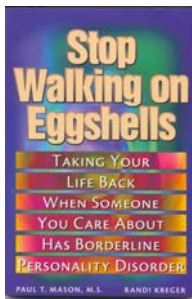
This is a fine book on a fairly obscure diagnosis in spite of the fact that over 6 million Americans suffer from BPD. It is chronic, disabling psychiatric condition that devastates lives. The book serves as a handbook on the diagnosis and as a map for who to traverse this mine field of self destructive behavior. Many who read it will recognize the traits of their loved on who has been such a dilemma.

BPD was not recognized by the DSM's manual until 1980 and "many mental health professionals miss signs of BPD because they're not educated enough about the disorder.

Some professional dismiss the diagnosis as a catchall designation or a new fad to describe difficult patients." pg. 19

Janice Cauwels is quoted as saying "Trying to define BPD is like staring into a lava lamp; what you see is constantly changing. The illness not only causes instability but symbolizes it."

"The very definition of a personality disorder is that it causes distress for both the person who has the disorder and those who interact with them." This book presents a compelling explanation of BPD.

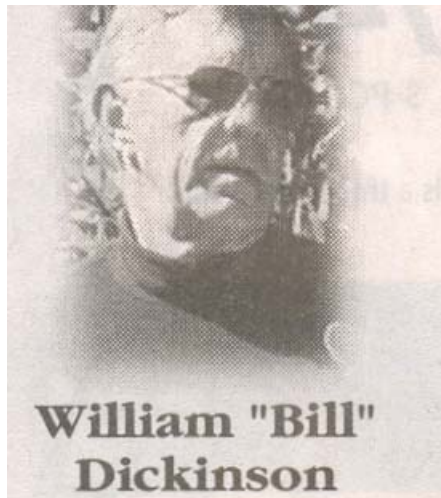
